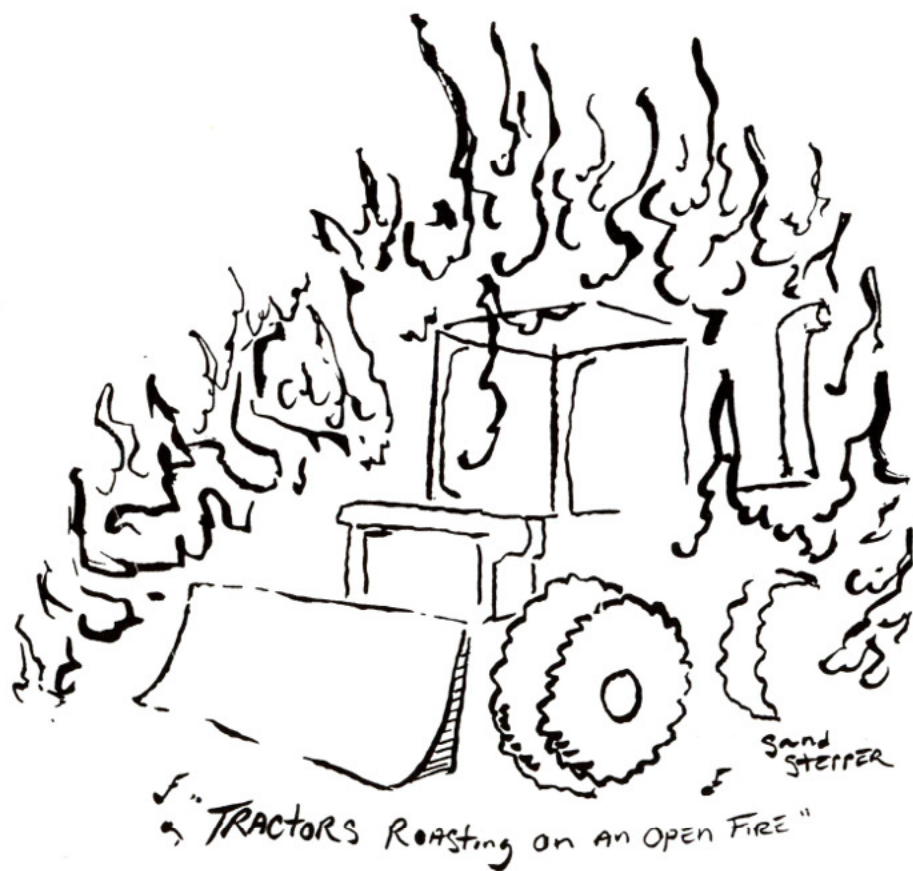

## **Court Reports & Legal Updates**

**JOSH HARPER ARRESTED** On 9/27/00 American eco/animal liberation-activist Josh Harper was arrested for Criminal Contempt after he failed to attend a grand jury which is investigating the activities of both the ELF & ALF. Josh has always stated that he will never testify against his fellow activists even if it will cost him his freedom. For his defiance the prosecution are talking about seeking a jail term of around two years. Please send donations to 'Josh Harper Support Fund', PO Box 45275, Seattle, WA 98145, USA. His next court date and trial is set for December 1<sup>st</sup> in Portland, OR.

**MOWING THE LAWN** Animal Liberation prisoner Justin Samuel has entered into a plea bargain. In return for grassing up his co-defendant, Peter Young, and for pleading Guilty to some misdemeanours, Samuel was sentenced to 2 years in prison, ordered to pay \$364,106 restitution, and given 1 year of supervision. Meanwhile another former ALF activist, Ron Blauch, from Long Island, New York, has grassed up his co-defendant Andy Stepanian. As a result of Blauch's grassing, on 20/11/00 Andy was sentenced to six months imprisonment (to start in January 2001).

**GREENPEACE 28 NOT GUILTY!** On 20/09/00 28 Greenpeace activists were found to have a lawful Excuse to destroy six acres of GM maize in Norfolk, England. The 28 had all been charged with causing Criminal Damage. However the Jury rejected the charge after the activists explained that they had to destroy the crop to prevent harmful GM pollution entering the environment.

**JOSE BOVE SENTENCED** On 13/09/00 French eco-activist Jose Bove was sentenced to three months imprisonment for leading an attack against a McDonalds construction site that caused £70,000 damage.

**ELAHO VALLEY TRIAL** On 15/09/00 eight Canadian eco-activists were found guilty of blocking logging roads in the Elaho Valley, Canada. The police accused the activists of either Civil or Criminal Contempt and some of the eight found themselves locked up

Betty Krawczyk, Burnaby Correctional Center for Women, 7900 Fraser Park Dr., Burnaby, BC V5J 5H1, Canada. Serving 1 year for blocking a road whilst trying to stop logging in the Elaho Valley.

Nikos Maziotis, c/o Dafni Vaganou, Ozortz 3, 10689 Athenes, Greece. Serving 15 years for bombing the Greek Ministry of Industry in protest at an attempt by TVX-Gold to build a factory in Strymonikos Bay.

Silvano Pellissero, Com. Mastrolerto, Via Ferrerinoli no2, Sanponso, 10080 Torino, Italy. Serving 6 years 8 months for allegedly sabotaging of a rail line construction site in the Northern Italian Alps

## **INDIGENOUS LAND RIGHTS**

Leonard Peltier #89637-132, PO Box 1000, Leavenworth, KS 66048, USA. An American Indian Movement (AIM) activist, serving two life sentences, having been framed for the murder of two FBI agents.

Robert Wilson #640289, Pack Unit 1, 2400 Wallace Pack Rd, Navasota, TX 77869, USA. In 1978 Robert (a.k.a. Standing Deer) exposed a government plot to assassinate Leonard Peltier. His reward was life in prison

Lenny Chavez, PO Box 28703, Oakland CA 94694 USA. An AIM activist who defended himself & his family from an armed racist. Lenny disarmed his attacker by stabbing him with a penknife.

## **MOVE**

MOVE is an eco-revolutionary group. There are currently eight MOVE activists in prison each serving 100 years after being framed for the murder of a cop in 1979. 9th defendant, Merle Africa, died in prison in 1998.

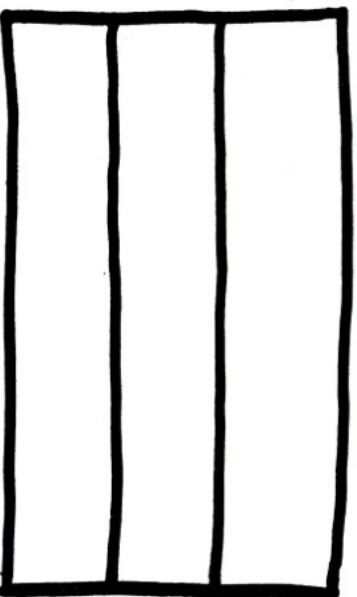
